### TERMS AND CONDITIONS

1. You will receive a donation each time a study participant indicates that his or her incentive compensation should be paid to your organization, and then successfully completes the study. If a participant fails to complete the study, no compensation is paid.
2. Compensation for a study is paid after results are collected and verified. A check is typically issued within 45 days of study completion. Each check is accompanied by a report indicating the name of the donor, the study they participated in, and the amount of the donation.
3. Insight Counts will provide your organization with a year-end summary of donations, including date, individual, and amount. If we do not have evidence of your tax-exempt status, we will provide the appropriate tax documents if compensation exceeds the IRS maximum.
4. Insight Counts cannot guarantee donations at any time, nor can we guarantee the amount of compensation you can expect to receive. Study participants qualify by meeting demographic criteria determined by the company sponsoring the study, and by willingness and availability to participate. Therefore, the more members or donors you have registered with Insight Counts, the greater the chance that some will qualify, and the greater your compensation is likely to be.
5. Information will not be released about participants while they are engaged in a study. Upon request, Insight Counts will provide estimates of expected donations to your organization but specific names are treated confidentially while a study is in progress.
6. The amount and type of compensation for each study is determined by the company sponsoring the testing and is determined before testing begins. Insight Counts has no control over the type or amount of compensation.
7. By enrolling as an Insight Counts partner, your organization's name will be available for selection on consumer panelist registration forms, study qualification surveys, and various other documents relating to the administration and support of consumer opinion tests. This does not constitute an endorsement of Insight Counts by your organization.
